
TYPICAL ADDITION RATE:

This product is designed to be used at a dosage of 1 kilo to 5,000 kg, or 200 mg/kg, to mark fuel oils in accordance with German national regulations.


APPEARANCE

SHELF LIFE AND STORAGE CONDITION

This product is stable for a minimum period of 2 year from the date of manufacture, when stored and handled between 5°C and 40°C.
