

This product is designed to be used at a dosage of 1 kilo to 25,000 litres fuel oils or 40mg/L.

APPEARANCE

DYEGUARD® GREEN MCSY is a free-flowing green liquid with a distinct aromatic odour. It is not miscible with water.



SHELF LIFE AND STORAGE CONDITION

This product is stable for a minimum period of 1 year from the date of manufacture, when stored and handled between 5°C and 40°C.

The product should always be stored away from excessive heat sources, direct sunlight or ignition sources. Storage and handling of this product outside the above stated conditions may compromise the product quality.

If product containers are kept sealed and dry and extreme temperatures are avoided the shelf life of the material is greater than 1 years. The container should be tightly closed when not in use in order to prevent solvent evaporation.
