
This product is designed to be used at a dosage of 1 kilo to 25,000 litres, or 40 mg/l, to mark fuel oils in accordance with national regulations.

SHELF LIFE AND STORAGE CONDITION

This product is stable for a minimum period of 2 years from the date of manufacture, when stored and handled between 5°C and 40°C.
